

Concentrated Potassium-Containing Solution Tracking Sheet – Patient Specific Supply

POTASSIUM CHLORIDE 10mmol/10mL Ampoules

- Standard premixed (diluted) bags containing potassium chloride are to be utilised in preference to non-standard solutions requiring preparation in all areas.
- Concentrated Potassium chloride products are only imprested on ICU at Bunbury Hospital.
- Concentrated Potassium chloride products, for non ICU patients, are to be sourced from Pharmacy. These are to be provided on an individual patient basis and unused ampoules are to be returned to Pharmacy once therapy has ceased.

- Concentrate Potassium dihydrogen phosphate ampoules are only stored in Pharmacy.
- These are to be provided on an individual patient basis for fluid restricted ICU patients only and unused ampoules are to be returned to Pharmacy once therapy has ceased.
