# Communiqué WA Country Health Service Board

This communiqué highlights key discussions and considerations from the Board's meeting.

## October 2017 Board Meeting

The Board meeting was part of a regional engagement visit to the West Pilbara. The visit

commenced on Thursday 26 October with discussions held with the WACHS Pilbara regional executive in Karratha before visiting the construction site of new \$207 million Karratha Health Campus (KHC). As part of the KHC site tour, the Board had the privilege of meeting Violet and Kathy Samson, two of the local Aboriginal artists who have created some magnificent art pieces that will be displayed in the new campus when it is opened later next year.



Travelling to Roebourne, the Board had the opportunity to meet with staff and a number of board members from Mawarnkarra Aboriginal Medical Service and see where the new facility to house four renal chairs for the community will be built. The visit to Roebourne was completed



with a meeting with the highly dedicated staff at Roebourne District Hospital.

During the two-day visit, the Board met with a number of business and community representatives, government agency officials, patients and clinicians and welcomed the open discussions and ideas in relation to future health service needs in the region.

The Board wished to thank the WACHS Pilbara regional executive and local staff for hosting their visit and congratulate them for the tremendous work they do in delivering a high standard of health care in a diverse and remote country region.
