July 2018 Board Meeting

The Board Meeting was held on Friday 27 July 2018, in Perth. The Board acknowledged Mr Joshua Nisbet, retiring Board member for his contribution over the past two years and welcomed two new Board members, Dr Diane Mohen and Ms Kelly Howlett. The WACHS Board is strongly representative of the communities it serves, with half of the Board now comprised of members who live and work in country Western Australia, and more than half of the WACHS Board members being female.

The Minister for Health attended part of the meeting, which included discussion on the Sustainable Health Review, safety of health service staff in the workplace, access to tertiary level health services by country patients, aged care services, regional commissioning pilot in the Kimberley, country ambulance services and health service infrastructure projects. This provided an opportunity for the Board to discuss with the Minister current issues in country health care and key priorities for the Board.
