and Derby Health Service. While in Fitzroy Crossing meetings were held with representatives from Nindilingarri Cultural Health Service and Kimberley Aboriginal Law and Cultural Centre. In Derby the Board met with the Derby Aboriginal Medical Service.

These are important meetings for the Board members, providing an opportunity to meet directly with staff and local stakeholders regarding their priorities and key issues for the local health services. The Board recognises the challenges in delivering

Key Matters for Decision

- The Board reviewed and endorsed the draft WACHS Mental Health and Wellbeing Strategy 2019 2024 for wider external consultation;
- Revisions to the WACHS Authorisation schedule were endorsed;
- The final version of the WACHS Digital Strategy was endorsed, with a review and refinement to be undertaken in twelve months.

Key Matters for Discussion

- The Chief Executive's report provided an update on monthly performance, projections and key developments within WACHS over the past month;
- The final report and recommendations of the Sustainable Health Review was a focal discussion with implementation of recommendations relating to country WA a lead issue for the Board.
- The outcomes of the final evaluation of the Southern Inland Health Initiative (SIHI), were reviewed, which highlighted a number of positive clinical outcomes had been achieved.
- The Board discussed the establishment of a set of principles to guide the development of a small community hospital strategy that will provide clarity on service profiles, allowing for flexibility in the delivery of services in smaller communities to be jointly developed with each community;
- The board discussed examining and aligning structures to enable greater regional services integration to deliver more people and community centred care. The concept was supported for further development.
