# Communiqué WA Country Health Service Board

This communiqué highlights key discussions from the WA Country Health Service (WACHS) Board's regional engagement meetings in the Kimberley region.

# 19-21 August 2020

The Board travelled to the East Kimberley region for the third regional engagement visit of 2020, with meetings and forums held in Halls Creek, Wyndham and Kununurra. On arrival at Halls Creek, the Board were welcomed by the Traditional Owners, with a Welcome to Country smoking ceremony performed at the airport.

The Board had the opportunity to visit Halls Creek Health Service, Wyndham District Hospital and Kununurra District Hospital, where local staff at each site provided a tour of the facilities and discussed key issues relevant to the health services. Staff were also able to present overviews of key initiatives and achievements across the region such as the future Safe Haven Café in Kununurra, as well discuss some of the challenges experienced in delivering mental health and transport services within the region.
