

# Communiqué WA Country Health Service Board

This communiqué highlights key discussions and considerations from the recent WA Country Health Service (WACHS) Board meeting.

#### 30 October 2020

The Board meeting was held in Perth at WACHS Central Office.

The meeting provided the Board with an opportunity to discuss several key matters, including place-based care perspectives, initiatives and strategies being undertaken to increase our Aboriginal workforce, the 2020-21 Budget allocations for WACHS, and the work undertaken to outline WACHS structural budget deficit and ongoing budget management challenges to the Cost Driver Project Working Group.

During the meeting, reports were received from the Safety and Quality and Audit and Risk Committees who both met on 13 October 2020, and the Finance Committee who met on 26 October 2020.

At the conclusion of the Board Meeting, the Minister for Health and the Acting Director General met with the WACHS Board to discuss key issues affecting country health services. The Minister highlighted the recent announcements for significant funding for WACHS projects, including the Bunbury redevelopment, Command Centre, and the Country Ambulance Strategy. The Board had an opportunity to highlight key WACHS strategic priorities to the Minister, including the development of a workforce strategy, small hospital sustainability and associated budget risks, the Mental Health Cultural Governance Framework, and the development of an Environmental Sustainability Framework.
