

# **BOARD COMMUNIQUÉ**

This communiqué highlights key discussions from the recent WA Country Health Service (WACHS) Board meeting.

#### 16 December 2022

The final Board meeting of the year was held in Perth on Friday, 16 December 2022 at WACHS' offices in Curtin University.

At the beginning of the meeting, a joint session was held with the WACHS Executive. This time was used to reflect back on the past few years, particularly on the many challenges WACHS faced but also to highlight the amazing initiatives and achievements our staff have led and delivered on.

The Chief Executive and Board Chair thanked Executive staff and their teams for their continued dedication and commitment to the delivery of care to country patients, and acknowledged the many achievements that, despite significant challenges, have all contributed to better health outcomes for country residents. The Chief Executive also thanked the Board for their continued guidance and support to WACHS and the Executive team.

The Board acknowledged the leadership of the Chief Executive, and thanked the Executive team for continuing to maintain service continuity whilst still remaining focused on progressing WACHS' strategic priorities.
